- **Oct 7, 2009:** Mr. Crowley moved to refer to Standards of Official Conduct.
- **Oct 7, 2009:** MOTION TO REFER PRIVILEGED RESOLUTION - Mr. Crowley moved to refer the privileged resolution to the Committee on Standards of Official Conduct and the Chair recognized Mr. Crowley under the 1 hour rule. Subsequently, Mr. Crowley moved the previous question on the motion to refer and by voice vote, the Chair announced that the ayes prevailed. Mr. Carter demanded a recorded vote on ordering the previous question on the motion to refer.
