Summary (as of Jun 17, 2010)

Recognizes the historical importance of the 60th anniversary of the outbreak of the Korean War, which began on June 25, 1950.

Honors the noble service and sacrifice of the U.S. Armed Forces and the armed forces of allied countries that served in Korea since 1950 to the present.

Encourages all Americans to participate in commemorative activities to pay solemn tribute to, and to never forget, the veterans of the Korean War.

Reaffirms the U.S. commitment to its alliance with the Republic of Korea for the betterment of peace and prosperity on the Korean Peninsula.

- **Jun 17, 2010:** Considered as unfinished business. (consideration: CR H4618)
- **Jun 17, 2010:** Passed/agreed to in House: On motion to suspend the rules and pass the resolution, as amended Agreed to by voice vote.(text: CR 6/16/2010 H4559-4560)
- **Jun 17, 2010:** On motion to suspend the rules and pass the resolution, as amended Agreed to by voice vote. (text: CR 6/16/2010 H4559-4560)
- **Jun 17, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 16, 2010:** Mr. Faleomavaega moved to suspend the rules and pass the resolution, as amended.
- **Jun 16, 2010:** Considered under suspension of the rules. (consideration: CR H4559-4564)
- **Jun 16, 2010:** DEBATE - The House proceeded with forty minutes of debate on H.J. Res. 86.
- **Jun 16, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Faleomavaega objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **May 25, 2010:** Introduced in House
- **May 25, 2010:** Referred to House Foreign Affairs
- **May 25, 2010:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on Armed Services, and Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
