Providing for consideration of the bill (S. 181) to amend title VII of the Civil Rights Act of 1964 and the Age Discrimination in Employment Act of 1967, and to modify the operation of the Americans with Disabilities Act of 1990 and the Rehabilitation Act of 1973, to clarify that a discriminatory compensation decision or other practice that is unlawful under such Acts occurs each time compensation is paid pursuant to the discriminatory compensation decision or other practice, and for other purposes.

Summary (as of Jan 26, 2009)

Sets forth the rule for consideration of the bill (S. 181) to amend title VII of the Civil Rights Act of 1964 and the Age Discrimination in Employment Act of 1967, and to modify the operation of the Americans with Disabilities Act of 1990 and the Rehabilitation Act of 1973, to clarify that a discriminatory compensation decision or other practice that is unlawful under such Acts occurs each time compensation is paid pursuant to the discriminatory compensation decision or other practice.

Actions Timeline

- **Jan 27, 2009:** Considered as privileged matter. (consideration: CR H532-535)
- **Jan 27, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 87.
- **Jan 27, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 87, the Chair put the question on ordering the previous question and by voice vote the ayes had prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Jan 27, 2009:** Considered as unfinished business. (consideration: CR H543-544)
- **Jan 27, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 252 - 175 (Roll no. 32). (consideration: CR H544)
- **Jan 27, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 252 - 174 (Roll no. 33).(text: CR H532)
- **Jan 27, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 252 - 174 (Roll no. 33). (text: CR H532)
- **Jan 27, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 26, 2009:** Introduced in House
- **Jan 26, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-5, by Ms. Pingree (ME).
- **Jan 26, 2009:** Rule provides for consideration of S. 181 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit. Measure will be considered read. Bill is closed to amendments.
- **Jan 26, 2009:** Placed on the House Calendar, Calendar No. 4.
