- **Jun 16, 2010:** Ms. Watson moved to suspend the rules and agree to the resolution, as amended.
- **Jun 16, 2010:** Considered under suspension of the rules. (consideration: CR H4548-4549)
- **Jun 16, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 879.
- **Jun 16, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Ms. Watson objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
