Sets forth the rule for consideration of the bill (H.R. 1) making supplemental appropriations for job preservation and creation, infrastructure investment, energy efficiency and science, assistance to the unemployed, and State and local fiscal stabilization, for the fiscal year ending September 30, 2009.

Actions Timeline

- **Jan 27, 2009:** Considered as privileged matter. (consideration: CR H535-543)
- **Jan 27, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 88.
- **Jan 27, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 88, the Chair put the question on ordering the previous question and by voice vote the ayes had prevailed. Mr. Dreier demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Jan 27, 2009:** Considered as unfinished business. (consideration: CR H545-546)
- **Jan 27, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 244 - 183 (Roll no. 34). (consideration: CR H545)
- **Jan 27, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 235 - 191 (Roll no. 35).(text: CR H536)
- **Jan 27, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 235 - 191 (Roll no. 35). (text: CR H536)
- **Jan 27, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 26, 2009:** Introduced in House
- **Jan 26, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-6, by Ms. Slaughter.
- **Jan 26, 2009:** All points of order against consideration of the bill except those arising under clause 9 or 10 of rule XXI, are waived. After general debate, the Committee shall rise without motion and no further consideration of the bill shall occur except pursuant to a subsequent order of the House.
- **Jan 26, 2009:** Placed on the House Calendar, Calendar No. 5.
