Summary (as of Apr 1, 2009)

Supports the goals and ideals of the Day of Silence (during which students vow to remain silent to bring attention to the harassment and discrimination faced by lesbian, gay, bisexual, and transgender people in schools). Encourages each state, city, and local education authority to adopt laws and policies to prohibit name-calling, bullying, harassment, and discrimination against students, teachers, and other school staff regardless of their sexual orientation and gender identity or gender expression.

Actions Timeline

- **May 14, 2009:** Referred to the Subcommittee on Early Childhood, Elementary, and Secondary Education.
- **Apr 27, 2009:** Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.
- **Apr 1, 2009:** Introduced in House
- **Apr 1, 2009:** Referred to House Education and Labor
- **Apr 1, 2009:** Referred to the Committee on Education and Labor, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 1, 2009:** Referred to House Judiciary
