Sets forth the rule for consideration of the bill (H.R. 4213) to amend the Internal Revenue Code of 1986 to extend certain expiring provisions.

- **Dec 9, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 955.
- **Dec 9, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 955, the Chair put the question on ordering the previous question on H.Res. 955 and by voice vote, announced that the ayes prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on H.Res. 955 until later in the legislative day.
