Expresses support for the designation of National Stalking Awareness Month to educate Americans about stalking.

Encourages efforts to promote awareness of stalking and the availability of services for stalking victims.

Urges national and community organizations, private businesses, and the media to promote, through National Stalking Awareness Month, awareness of the crime of stalking.

- **Feb 4, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by voice vote.(text: CR 2/2/2010 H440)
- **Feb 4, 2010:** On motion to suspend the rules and agree to the resolution Agreed to by voice vote. (text: CR 2/2/2010 H440)
- **Feb 4, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 2, 2010:** Mr. Johnson (GA) moved to suspend the rules and agree to the resolution.
- **Feb 2, 2010:** Considered under suspension of the rules. (consideration: CR H440-442)
- **Feb 2, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 960.
- **Feb 2, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Johnson (GA) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.

- **Dec 9, 2009:** Referred to the House Committee on the Judiciary.
