## Summary (as of Sep 10, 2009)

Chesapeake Bay Gateways and Watertrails Network Continuing Authorization Act - Amends the Chesapeake Bay Initiative Act of 1998 to make permanent the authorization of appropriations for the Chesapeake Bay Gateways and Watertrails Network.

## Actions Timeline

- **Oct 14, 2009:** Read twice and referred to the Committee on Environment and Public Works.
- **Sep 10, 2009:** Rule H. Res. 726 passed House.
- **Sep 10, 2009:** Considered under the provisions of rule H. Res. 726. (consideration: CR H9402-9409, H9409-9410)
- **Sep 10, 2009:** Rule provides for consideration of H.R. 965 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. A specified amendment is in order. All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI.
- **Sep 10, 2009:** DEBATE - The House proceeded with one hour of debate on H.R. 965.
- **Sep 10, 2009:** DEBATE - Pursuant to the provisions of H.Res. 726, the House proceeded with 20 minutes of debate on the Bishop (UT) amendment.
- **Sep 10, 2009:** DEBATE - The House continued with further debate on the Bishop (UT) amendment.
- **Sep 10, 2009:** Mr. Hastings (WA) moved to recommit with instructions to Natural Resources. (consideration: CR H9407-9409; text: CR H9407)
- **Sep 10, 2009:** DEBATE - The House proceeded with 10 minutes of debate on the Hastings (WA) motion to recommit with instructions. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment stating that the authorization for appropriations declared in Section 2 of the bill shall not take effect until the national deficit is less than \$1,000,000,000,000.
- **Sep 10, 2009:** The previous question on the motion to recommit with instructions was ordered without objection. (consideration: CR H9408)
- **Sep 10, 2009:** On motion to recommit with instructions Failed by the Yeas and Nays: 194 - 229 (Roll no. 694). (consideration: CR H9408-9409)
- **Sep 10, 2009:** Passed/agreed to in House: On passage Passed by recorded vote: 311 - 107 (Roll no. 695). (text: CR H9402)
- **Sep 10, 2009:** On passage Passed by recorded vote: 311 - 107 (Roll no. 695). (text: CR H9402)
- **Sep 10, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 10, 2009:** Received in the Senate.
