### **Actions Timeline**

- **Dec 16, 2009:** Introduced in House
- **Dec 16, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-380, by Ms. Pingree (ME).
- **Dec 16, 2009:** Rule provides for consideration of H.R. 3326, H.J. Res. 64, H.R. 4314 and H.R. 2847.
- **Dec 16, 2009:** Placed on the House Calendar, Calendar No. 146.
- **Dec 16, 2009:** By direction of the Committee on Rules, Ms. Pingree (ME) called up H.Res. 976 and asked for its immediate consideration.
- **Dec 16, 2009:** POINT OF ORDER - Mr. Flake raised a point of order against the provisions of H.Res. 976 on the grounds that it violated the Congressional Budget Act. The Chair announced that the disposition of the point of order would be resolved by the question of consideration of H.Res. 976. The House proceeded with 20 minutes of debate on the point of order at the end of which the Chair will put the question on consideration.
- **Dec 16, 2009:** On question of consideration of the resolution Agreed to by voice vote. (consideration: CR H14996)
- **Dec 16, 2009:** Considered as privileged matter. (consideration: CR H14994-15006)
- **Dec 16, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 976.
- **Dec 16, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 235 - 193 (Roll no. 982). (consideration: CR H15005)
- **Dec 16, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 228 - 201 (Roll no. 983).(text: CR H14994-14995)
- **Dec 16, 2009:** On agreeing to the resolution Agreed to by recorded vote: 228 - 201 (Roll no. 983). (text: CR H14994-14995)
