Summary (as of Mar 15, 2011)

Repealing Ineffective and Incomplete Abstinence-Only Program Funding Act of 2011 - Amends title V (Maternal and Child Health Services) of the Social Security Act to: (1) eliminate the abstinence-only education program, (2) rescind unobligated FY2010-FY2011 program appropriations, and (3) reprogram such rescinded appropriations for the personal responsibility education program (PREP) for FY2012-FY2014.

Actions Timeline

- **Mar 28, 2011:** Referred to the Subcommittee on Health.
- **Mar 15, 2011:** Introduced in House
- **Mar 15, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
