Reduces by 10% the amounts authorized to be appropriated to the Department of Defense (DOD) for FY2012 for printing and reproduction under Army, Navy, Marine Corps, Air Force, and defense-wide operation and maintenance funds.

Actions Timeline

- **May 18, 2011:** Referred to the Subcommittee on Readiness.
- **Apr 5, 2011:** Received in the Senate and Read twice and referred to the Committee on Armed Services.
- **Apr 4, 2011:** Mr. West moved to suspend the rules and pass the bill.

- **Apr 4, 2011:** DEBATE - The House proceeded with forty minutes of debate on H.R. 1246.
- **Apr 4, 2011:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
