Authorizes Emancipation Hall in the Capitol Visitor Center to be used on June 27, 2012, for an event to award the Congressional Gold Medal, collectively, to the Montford Point Marines. (Camp Montford Point, North Carolina, was the site for the training of the first African-American Marines.)
