To prohibit Members of Congress, including the Delegates and the Resident Commissioner to the Congress, and the President from receiving pay during Government shutdowns.

Summary (as of Mar 31, 2011)

Prohibits Members of Congress, including Delegates and the Resident Commissioner, and the President from receiving basic pay for any period in which: (1) there is more than a 24-hour lapse in appropriations for any federal agency or department as a result of a failure to enact a regular appropriations bill or continuing resolution, or (2) the federal government is unable to make payments or meet obligations because the public debt limit has been reached.

Prohibits retroactive payment of such forfeited pay.

Actions Timeline

- **Apr 1, 2011:** Referred to the Subcommittee on Federal Workforce, U.S. Postal Service, and Labor Policy.
- **Mar 31, 2011:** Introduced in House
- **Mar 31, 2011:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
