## Summary (as of Jan 10, 2013)

**(This measure has not been amended since it was passed by the House on March 28, 2012. The summary of that version is repeated here.)**

Designates Salem, Massachusetts, as the Birthplace of the National Guard of the United States.

Directs the Chief of the National Guard Bureau to provide military ceremonial support at the dedication of any monument, plaque, or other official recognition celebrating such designation. Prohibits federal funds from being used in connection with such recognition.
