Summary (as of Jan 5, 2011)

Amends the Internal Revenue Code to establish in the Treasury the Homeless Veterans Assistance Fund and to allow individual taxpayers to designate on their tax returns \$3.00 of income taxes (\$6.00 in the case of joint returns) to be paid over to such Fund to provide assistance to homeless veterans.

Actions Timeline

- **Feb 18, 2011:** Referred to the Subcommittee on Health.
- **Jan 5, 2011:** Introduced in House
- **Jan 5, 2011:** Referred to the Committee on Ways and Means, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
