Summary (as of Jan 5, 2011)

Revoke Excessive Policies that Encroach on American Liberties (REPEAL) Act - Repeals the Patient Protection and Affordable Care Act and the health care provisions of the Health Care and Education Reconciliation Act of 2010, effective as of their enactment. Restores or revives provisions amended or repealed by such Act or such health care provisions.

Actions Timeline

- **Feb 25, 2011:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Feb 1, 2011:** Referred to the Subcommittee on Health.
- **Jan 26, 2011:** Referred to the Subcommittee Indian and Alaska Native Affairs.
- **Jan 5, 2011:** Introduced in House
- **Jan 5, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, the Judiciary, Natural Resources, House Administration, Rules, and Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
