Sets forth the rule for consideration of the joint resolution (H.J. Res. 48) making further continuing appropriations for fiscal year 2011.

Actions Timeline

- **Mar 15, 2011:** Considered as privileged matter. (consideration: CR H1806-1810)
- **Mar 15, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 167.
- **Mar 15, 2011:** The previous question was ordered without objection. (consideration: CR H1810)
- **Mar 15, 2011:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 167, the Chair put the question on agreeing to the resolution, and by voice vote, announced that the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption until later in the legislative day.
