FISA Sunsets Reauthorization Act of 2011 - Amends the USA PATRIOT Improvement and Reauthorization Act of 2005 to extend through 2017 a provision granting roving electronic surveillance authority.

Amends the Intelligence Reform and Terrorism Prevention Act of 2004 to make permanent a provision revising the definition of an "agent of a foreign power" to include any non-U.S. person who engages in international terrorism or preparatory activities ("lone wolf" provision).

- **May 11, 2011:** Mr. Lungren, Daniel E. asked unanimous consent that the Committee on Judiciary have until 5:00 p.m. on May 18 to file a report on H.R. 1800. Agreed to without objection.
- **May 6, 2011:** Introduced in House
- **May 6, 2011:** Referred to the Committee on the Judiciary, and in addition to the Committee on Intelligence (Permanent Select), for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
