Summary (as of May 11, 2011)

Industrial Hemp Farming Act of 2011 - Amends the Controlled Substances Act to exclude industrial hemp from the definition of "marijuana." Defines "industrial hemp" to mean the plant Cannabis sativa L. and any part of such plant, whether growing or not, with a delta-nine tetrahydrocannabinol concentration of not more than 0.3 percent on a dry weight basis. Deems Cannabis sativa L. to meet that concentration limit if a person grows or processes it for purposes of making industrial hemp in accordance with state law.

Actions Timeline

- Jun 1, 2011: Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- May 13, 2011: Referred to the Subcommittee on Health.
- May 11, 2011: Introduced in House
- May 11, 2011: Sponsor introductory remarks on measure. (CR E869)
- May 11, 2011: Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
