## Summary (as of May 23, 2011)

Medicare Access to Diabetes Supplies Act of 2011 - Amends title XVIII (Medicare) of the Social Security Act to exempt from Medicare competitive acquisition programs blood glucose self-testing equipment and supplies furnished by small retail community pharmacies.

## Actions Timeline

---

- **May 31, 2011:** Referred to the Subcommittee on Health.
- **May 23, 2011:** Introduced in House
- **May 23, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **May 23, 2011:** Referred to the Subcommittee on Health.
