Summary (as of Feb 28, 2012)

Protecting Academic Freedom in Higher Education Act - Repeals certain Department of Education regulations that for purposes of determining whether a school is eligible to participate in programs under the Higher Education Act of 1965 (HEA): (1) require institutions of higher education and postsecondary vocational institutions (except religious schools) to be legally authorized by the state in which they are situated, (2) delineate what such legal authorization requires of states and schools, and (3) define "credit hour."

Prohibits the Secretary of Education from promulgating or enforcing any regulation or rule that defines "credit hour" for any purpose under the HEA.

Actions Timeline

- **Feb 29, 2012:** Received in the Senate and Read twice and referred to the Committee on Health, Education, Labor, and Pensions.
- **Feb 28, 2012:** Rule H. Res. 563 passed House.
- **Feb 28, 2012:** Considered under the provisions of rule H. Res. 563. (consideration: CR H980-992)
- **Feb 28, 2012:** Rule provides for consideration of H.R. 2117 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Specified amendments are in order. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Education and the Workforce now printed in the bill.
- **Feb 28, 2012:** House resolved itself into the Committee of the Whole House on the state of the Union pursuant to H. Res. 563 and Rule XVIII.
- **Feb 28, 2012:** The Speaker designated the Honorable Candice S. Miller to act as Chairwoman of the Committee.
- **Feb 28, 2012:** GENERAL DEBATE - The Committee of the Whole proceeded with one hour of general debate on H.R. 2117.
- **Feb 28, 2012:** DEBATE - Pursuant to the provisions of H. Res. 563, the Committee of the Whole proceeded with 10 minutes of debate on the Grijalva amendment No. 1.
- **Feb 28, 2012:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Grijalva amendment, the Chair put the question on adoption of the amendment and by voice vote announced that the noes had prevailed. Mr. Grijalva demanded a recorded vote and the Chair postponed further proceedings on the question of adoption of the amendment until later in the legislative day.
- **Feb 28, 2012:** DEBATE - Pursuant to the provisions of H. Res. 563, the Committee of the Whole proceeded with 10 minutes of debate on the Foxx amendment No. 2.
- **Feb 28, 2012:** DEBATE - Pursuant to the provisions of H. Res. 563, the Committee of the Whole proceeded with 10 minutes of debate on the Polis amendment No. 3.

- **Feb 28, 2012:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Polis amendment, the Chair put the question on adoption of the amendment and by voice vote announced that the ayes had prevailed. Ms. Foxx demanded a recorded vote and the Chair postponed further proceedings on the question of adoption of the amendment until later in the legislative day.
- **Feb 28, 2012:** Ms. Foxx moved that the committee rise.
- **Feb 28, 2012:** On motion that the committee rise Agreed to by voice vote.
- **Feb 28, 2012:** Committee of the Whole House on the state of the Union rises leaving H.R. 2117 as unfinished business.

- **Feb 28, 2012:** Mrs. Capps moved to recommit with instructions to Education and the Workforce. (consideration: CR H995-996; text: CR H995)
- **Feb 28, 2012:** DEBATE - The House proceeded with 10 minutes of debate on the Capps motion to recommit. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment which adds a provision entitled "PROTECTING STUDENTS FROM HIGHER LOAN COSTS AND A DEVALUED EDUCATIONAL DEGREE".
