Summary (as of Jan 7, 2011)

Repeals the Patient Protection and Affordable Care Act, except provisions related to the Indian Health Care Improvement Reauthorization and Extension Act of 2009, and the health care provisions of the Health Care and Education Reconciliation Act of 2010, effective in 60 days. Restores or revives provisions amended or repealed by such Act or such health care provisions.

Actions Timeline

- **Feb 25, 2011:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Feb 1, 2011:** Referred to the Subcommittee on Health.
- **Jan 7, 2011:** Introduced in House
- **Jan 7, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Education and the Workforce, Ways and Means, House Administration, Rules, the Judiciary, and Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
