Summary (as of Jun 14, 2011)

Congressional Integrity and Pension Forfeiture Act of 2011 - Extends provisions requiring forfeiture of pension benefits under the Civil Service Retirement System (CSRS) and the Federal Employees' Retirement System (FERS) to the President, Vice President, or an elected state or local government official, in addition to Members of Congress, upon conviction of a serious public corruption crime. Expands the list of such crimes that would require a pension forfeiture.

Actions Timeline

- **Jun 20, 2011:** Referred to the Subcommittee on Federal Workforce, U.S. Postal Service, and Labor Policy .
- **Jun 14, 2011:** Introduced in House
- **Jun 14, 2011:** Referred to the Committee on House Administration, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
