Summary (as of Jun 16, 2011)

Employment Impact Act of 2011 - Requires federal agencies to: (1) assess the impact of federal actions on jobs and job opportunities, (2) include in every recommendation or report on legislative proposals and regulatory actions a jobs impact statement, and (3) review their statutory authority, regulations, and policies and procedures to ensure compliance with the purposes and provisions of this Act.

Exempts implementation of this Act, including such job impact statements, from judicial review.

- **Jun 16, 2011:** Introduced in House
- **Jun 16, 2011:** Referred to the House Committee on Oversight and Government Reform.
