Summary (as of Jun 21, 2011)

Home Health Care Planning Improvement Act of 2011 - Amends title XVIII (Medicare) of the Social Security Act to revise conditions of and limitations on payment for home health care services.

Allows payment for home health services to Medicare beneficiaries by: (1) a nurse practitioner, (2) a clinical nurse specialist working in collaboration with a physician in accordance with state law, (3) a certified nurse-midwife, or (4) a physician assistant under a physician's supervision.

Actions Timeline

- **Jul 7, 2011:** Referred to the Subcommittee on Health.
- **Jun 22, 2011:** Referred to the Subcommittee on Health.
- **Jun 21, 2011:** Introduced in House
- **Jun 21, 2011:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
