Summary (as of Jun 22, 2011)

Prohibits, unless otherwise specifically authorized by law, funds appropriated or otherwise available to the Department of Defense (DOD) from being obligated or expended for U.S. Armed Forces in support of the North Atlantic Treaty Organization Operation Unified Protector with respect to Libya, except for: (1) search and rescue; (2) intelligence, surveillance, and reconnaissance; (3) aerial refueling; and (4) operational planning.

Actions Timeline

- **Jun 24, 2011:** Considered under the provisions of rule H. Res. 328. (consideration: CR H4550-4564; text as introduced in House: CR H4550)
- **Jun 24, 2011:** Rule provides for consideration of H.J. Res. 68 and H.R. 2278 with 1 hour of general debate. Motion to recommit with or without instructions is allowed. Will be considered read. Bill is closed to amendments. The rule provides one hour of debate on H.J.Res. 68 with 40 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Foreign Affairs and 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Armed Services. All points of order against consideration and provisions are waived.
- **Jun 24, 2011:** DEBATE - The House proceeded with one hour of debate on H.R. 2278.
- **Jun 24, 2011:** The previous question was ordered pursuant to the rule. (consideration: CR H4563)
- **Jun 24, 2011:** Failed of passage/not agreed to in House: On passage Failed by recorded vote: 180 - 238 (Roll no. 494).
