Equal Access to COBRA Act of 2011 - Amends the Internal Revenue Code, the Employee Retirement Income Security Act (ERISA), and Public Health Service Act to expand COBRA coverage (health insurance continuation benefits) to include an employee's domestic partner and any dependent child of the domestic partner.

Actions Timeline

- **Sep 8, 2011:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Jul 7, 2011:** Referred to the Subcommittee on Health.
- **Jun 24, 2011:** Referred to the Subcommittee on Health.
- **Jun 23, 2011:** Introduced in House
- **Jun 23, 2011:** Referred to the Committee on Education and the Workforce, and in addition to the Committees on Energy and Commerce, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
