## Summary (as of Jun 23, 2011)

Amends the Bretton Woods Agreements Act to repeal authority to: (1) provide certain loans to the International Monetary Fund (IMF), including loans related to the New Arrangements to Borrow (NAB); (2) increase the U.S. quota in the IMF; and (3) approve the sale of IMF gold.

Rescinds related appropriations.

## Actions Timeline

- **Jul 19, 2011:** Referred to the Subcommittee on International Monetary Policy and Trade.
- **Jun 23, 2011:** Introduced in House
- **Jun 23, 2011:** Referred to the Committee on Financial Services, and in addition to the Committee on Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
