Government Waste Isolation Pilot Plant Extension Act of 2011- Directs the Secretary of Energy to manage the Waste Isolation Pilot Plant (WIPP) in such a way as to include the transportation and disposal of any non-defense federally-owned transuranic waste meeting certain criteria described in the document entitled "Transuranic Waste Acceptance Criteria For The Waste Isolation Pilot Plant," published by the Department of Energy (DOE) on April 21, 2011.

Actions Timeline

- **Aug 15, 2011:** Referred to the Subcommittee on Strategic Forces.
- **Jun 24, 2011:** Introduced in House
- **Jun 24, 2011:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 24, 2011:** Referred to the Subcommittee on Environment and the Economy.
