Actions Timeline

- **Aug 18, 2011:** Committee on Homeland Security and Governmental Affairs referred to Subcommittee on Federal Financial Management, Government Information, Federal Services, and International Security.
- **Jul 29, 2011:** Received in the Senate and Read twice and referred to the Committee on Homeland Security and Governmental Affairs.
- **Jul 28, 2011:** Mr. Lankford moved to suspend the rules and pass the bill.
- **Jul 28, 2011:** Considered under suspension of the rules. (consideration: CR H5721-5722)
- **Jul 28, 2011:** DEBATE - The House proceeded with forty minutes of debate on H.R. 2548.
- **Jul 28, 2011:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Lankford objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Jul 28, 2011:** Considered as unfinished business. (consideration: CR H5729)
- **Jul 28, 2011:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H5721)
- **Jul 28, 2011:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H5721)
- **Jul 28, 2011:** Motion to reconsider laid on the table Agreed to without objection.
