Sets forth the rule for consideration of the bill (H.R. 754) to authorize appropriations for fiscal year 2011 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System.

- **May 12, 2011:** Considered as privileged matter. (consideration: CR H3232-3237)
- **May 12, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 264.
- **May 12, 2011:** The previous question was ordered without objection. (consideration: CR H3237)
- **May 12, 2011:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 264, the Chair put the question on adoption of H.Res. 264 and by voice vote, announced that the ayes had prevailed. Mr. Hastings(FL) demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of H.Res. 264 until later in the legislative day.
- **May 12, 2011:** Considered as unfinished business. (consideration: CR H3243-3244)
- **May 12, 2011:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 251 - 133 (Roll no. 322).(text: CR H3232)
- **May 12, 2011:** On agreeing to the resolution Agreed to by the Yeas and Nays: 251 - 133 (Roll no. 322). (text: CR H3232)
- **May 12, 2011:** Motion to reconsider laid on the table Agreed to without objection.
- **May 11, 2011:** Introduced in House
- **May 11, 2011:** The House Committee on Rules reported an original measure, H. Rept. 112-75, by Mr. Sessions.
- **May 11, 2011:** The resolution waives all points of order against the committee amendment in the nature of a substitute. The amendment in the nature of a substitute recommended by the Permanent Select Committee on Intelligence now printed in the bill shall be considered as an original bill for the purpose of amendment under the five-minute rule. All points of order against the amendments are waived.
- **May 11, 2011:** Placed on the House Calendar, Calendar No. 36.
