Federal Aviation Employees Protection Act of 2011 - Amends the Internal Revenue Code to make amounts in the Airport and Airway Trust Fund available to pay personnel compensation and benefits for Federal Aviation Administration (FAA) employees funded from appropriations or authorizations provided on or before July 22, 2011.

- **Aug 1, 2011:** Introduced in House
- **Aug 1, 2011:** Sponsor introductory remarks on measure. (CR E1463-1464)
- **Aug 1, 2011:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
