Sets forth the rule for consideration of H.R. 1540 (National Defense Authorization Act for Fiscal Year 2012).

## Actions Timeline

- **May 25, 2011:** Considered as privileged matter. (consideration: CR H3423-3430; text of measure as introduced: CR H3423-3424)
- **May 25, 2011:** Point of order raised by Mr. Garamendi on the content of the measure. Mr. Garamendi made point of order against the measure and the Chair announced that the disposition of the point of order would be resolved by the question of consideration on H.Res. 276. The House proceeded with 20 minutes of debate on the point of order, and if necessary, the Chair will put the question on consideration. Point of order overruled by the Chair.
- **May 25, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 276.
- **May 25, 2011:** POSTPONED PROCEEDINGS - The Chair put the question on adoption of the amendment and on ordering the previous question on the resolution, and by voice vote announced that the ayes had prevailed. Mr. McGovern demanded a recorded vote and the Chair postponed further proceedings on adoption of the amendment and order the previous question until later in the legislative day.
- **May 25, 2011:** Considered as unfinished business. (consideration: CR H3434-3436)
- **May 25, 2011:** On ordering the previous question Agreed to by the Yeas and Nays: 239 - 181 (Roll no. 341). (consideration: CR H3430, H3435)
- **May 25, 2011:** Passed/agreed to in House: On agreeing to the resolution, as amended Agreed to by recorded vote: 243 - 170 (Roll no. 342).
- **May 25, 2011:** On agreeing to the resolution, as amended Agreed to by recorded vote: 243 - 170 (Roll no. 342).
- **May 25, 2011:** Motion to reconsider laid on the table Agreed to without objection.
- **May 24, 2011:** Introduced in House
- **May 24, 2011:** The House Committee on Rules reported an original measure, H. Rept. 112-88, by Mr. Bishop (UT).
- **May 24, 2011:** It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Armed Services now printed in the bill.
- **May 24, 2011:** Placed on the House Calendar, Calendar No. 40.
