## Summary (as of Jan 12, 2011)

---

Amends the the Illegal Immigration Reform and Immigrant Responsibility Act of 1996 to require federal contractors and subcontractors to participate in the E-Verify Program.

Directs the Secretary of Homeland Security (DHS) to ensure that the Program is applied to all of the contractor's or subcontractor's employees and not just to those performing the contract or subcontract.

## Actions Timeline

- **Feb 7, 2011:** Referred to the Subcommittee on Immigration Policy and Enforcement.
- **Jan 12, 2011:** Introduced in House
- **Jan 12, 2011:** Referred to the Committee on the Judiciary, and in addition to the Committee on Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
