Summary (as of Sep 15, 2011)

Small Business Administration Express Loan Extension Act of 2011 - Amends the Small Business Jobs Act of 2010 to extend through September 27, 2012 (under current law, until September 27, 2011) a temporary increase from \$350,000 to \$1 million in the maximum loan amount under the Express Loan Program of the Small Business Administration (SBA).
