Summary (as of Oct 26, 2011)

Amends the Federal Election Campaign Act of 1971 to apply it specifically to American Samoa, the Commonwealth of the Northern Mariana Islands, Guam, or the United States Virgin Islands.

Applies to such jurisdictions specified criminal penalties relating to the intimidation of voters, interference by government employees, and voting by aliens.

Actions Timeline

- **Nov 2, 2011:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Nov 2, 2011:** Referred to the Subcommittee on the Constitution.
- **Oct 26, 2011:** Introduced in House
- **Oct 26, 2011:** Referred to the Committee on the Judiciary, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
