Summary (as of Nov 3, 2011)

Standard Data and Technology Advancement Act or Standard DATA Act - Amends part A of title XI of the Social Security Act to direct the head of the department or agency responsible for administering certain human services programs to designate, by rule, nonproprietary and interoperable standard data elements for any category of information required to be reported.

Actions Timeline

- **Nov 3, 2011:** Introduced in House
- **Nov 3, 2011:** Sponsor introductory remarks on measure. (CR E1992-1993)
- **Nov 3, 2011:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
