Amends the Internal Revenue Code to: (1) establish in the Treasury the Homeless Veterans Assistance Fund, and (2) allow individual taxpayers to designate on their tax returns a specified portion (not less than \$1) of any overpayment of tax to be paid over to such Fund to provide services to homeless veterans.

Actions Timeline

- **Nov 10, 2011:** Referred to the Subcommittee on Health.
- **Nov 3, 2011:** Introduced in House
- **Nov 3, 2011:** Referred to the Committee on Ways and Means, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
