Summary (as of Jul 14, 2011)

Expresses the sense of the House of Representatives that the United States Postal Service (USPS) should: (1) issue a semipostal stamp to support medical research relating to Alzheimer's disease, and (2) transfer to the National Institutes of Health (NIH) for that purpose any amounts becoming available from the sale of that stamp.

Actions Timeline

- **Jul 15, 2011:** Referred to the Subcommittee on Health.
- **Jul 14, 2011:** Introduced in House
- **Jul 14, 2011:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
