## Summary (as of Nov 29, 2011)

Multinational Species Conservation Funds Semipostal Stamp Reauthorization Act - Amends the Multinational Species Conservation Funds Semipostal Stamp Act of 2010 to require such stamp to be: (1) made available to the public for an additional four years; and (2) offered in a a choice of five versions depicting an African or Asian elephant, a rhinoceros, a tiger, a marine turtle, or a great ape.

## Actions Timeline

- **Dec 5, 2011:** Referred to the Subcommittee on Fisheries, Wildlife, Oceans, and Insular Affairs.
- **Nov 29, 2011:** Introduced in House
- **Nov 29, 2011:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
