Sets forth the rule for consideration of the bill (H.R. 1938) to direct the President to expedite the consideration and approval of the construction and operation of the Keystone XL oil pipeline.

Actions Timeline

- **Jul 26, 2011:** Considered as privileged matter. (consideration: CR H5504-5507)
- **Jul 26, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 370.
- **Jul 26, 2011:** The previous question was ordered without objection. (consideration: CR H5506)
- **Jul 26, 2011:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 370, the Chair put the question on agreeing to the resolution and by voice vote, announced that the ayes had prevailed. Mr. Hastings(FL) demanded the yeas and nays and the Chair postponed further proceedings on agreeing to the resolution until a time to be announced.
- **Jul 26, 2011:** Considered as unfinished business. (consideration: CR H5507)
- **Jul 26, 2011:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 246 - 171 (Roll no. 637).(text: CR H5504)
