Summary (as of Jan 25, 2012)

Medicare Hospice Care Access Act of 2012 - Amends title XVIII (Medicare) of the Social Security Act to recognize attending physician assistants as attending physicians to serve hospice patients.

Actions Timeline

- **Feb 1, 2012:** Referred to the Subcommittee on Health.
- **Jan 25, 2012:** Introduced in House
- **Jan 25, 2012:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
