Summary (as of Feb 14, 2012)

Energy Assistance for American Families Act - Amends the Low-Income Home Energy Assistance Act of 1981 to authorize appropriations for FY2013-FY2016.

Permits a state to use any allotment from such appropriations to assist households whose income does not exceed 75% of the state median income.

Actions Timeline

- **Mar 29, 2012:** Referred to the Subcommittee on Higher Education and Workforce Training.
- **Feb 14, 2012:** Introduced in House
- **Feb 14, 2012:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
