Summary (as of Jan 25, 2011)

Small Business Tax Relief Act of 2011 - Repeals the provision of the Patient Protection and Affordable Care Act that extends to corporations that are not tax-exempt the requirement to report payments of \$600 or more.

Amends the Internal Revenue Code to impose a 5.4% surcharge on individual taxpayers whose modified adjusted gross income exceeds \$1 million. Dedicates revenues from such surcharge to federal deficit or debt reduction.
