- **Jan 24, 2011:** Considered as privileged matter. (consideration: CR H403-414)
- **Jan 24, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 43.
- **Jan 24, 2011:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 43, the Chair put the question on ordering the previous question and by voice vote announced that the ayes had prevailed. Mr. Dreier demanded the yeas and nays, and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Jan 24, 2011:** Considered as unfinished business. (consideration: CR H415-416)
- **Jan 24, 2011:** On ordering the previous question Agreed to by the Yeas and Nays: 238 - 174 (Roll no. 17). (consideration: CR H414, H415)
- **Jan 24, 2011:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 240 - 168 (Roll no. 18).(text: CR H403)
- **Jan 24, 2011:** On agreeing to the resolution Agreed to by recorded vote: 240 - 168 (Roll no. 18). (text: CR H403)
- **Jan 24, 2011:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 19, 2011:** Introduced in House
- **Jan 19, 2011:** The House Committee on Rules reported an original measure, H. Rept. 112-4, by Mr. Dreier.
- **Jan 19, 2011:** The resolution provides that the amendment in the nature of a substitute recommended by the Committee on Rules shall be considered as adopted. All points of order against consideration of the resolution are waived.
- **Jan 19, 2011:** Placed on the House Calendar, Calendar No. 4.
