Sets forth the rule for consideration of the bill (H.R. 2838) to authorize appropriations for the Coast Guard for fiscal years 2012 through 2015.

Actions Timeline

- **Nov 4, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 455.

Ms. Slaughter demanded the yeas and nays, and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.

- **Nov 4, 2011:** Motion to reconsider laid on the table Agreed to without objection.
- **Nov 3, 2011:** Introduced in House
- **Nov 3, 2011:** The House Committee on Rules reported an original measure, H. Rept. 112-267, by Mr. Webster.
- **Nov 3, 2011:** The resolution makes in order as original text for the purpose of amendment an amendment in the nature of a substitute consisting of the text of the Rules Committee Print of H.R. 2838 dated October 21, 2011. All points of order against the amendment in the nature of a substitute made in order as original text are waived. At any time on the legislative day of November 4, 2011, it shall be in order for the Speaker to entertain motions that the House suspend the rules relating to a measure addressing the applicability of the coastwise trade laws.
