Sets forth the rule for consideration of the bill (H.R. 822) to amend title 18, United States Code, to provide a national standard in accordance with which nonresidents of a State may carry concealed firearms in the State.

Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until a time to be announced.
