Sets forth the rule for consideration of the bill (H.R. 3094) to amend the National Labor Relations Act with respect to representation hearings and the timing of elections of labor organizations under that Act.

- **Nov 18, 2011:** DEBATE - The House proceeded with one hour of debate on H. Res. 470.
- **Nov 18, 2011:** The previous question was ordered without objection. (consideration: CR H7840)
- **Nov 18, 2011:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 470, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until a time to be announced.
- **Nov 18, 2011:** Considered as unfinished business. (consideration: CR H7874-7875)
- **Nov 18, 2011:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 239 - 167 (Roll no. 859). (text: CR H7835)
- **Nov 18, 2011:** On agreeing to the resolution Agreed to by the Yeas and Nays: 239 - 167 (Roll no. 859). (text: CR H7835)
- **Nov 18, 2011:** Motion to reconsider laid on the table Agreed to without objection.
- **Nov 17, 2011:** Introduced in House
- **Nov 17, 2011:** The House Committee on Rules reported an original measure, H. Rept. 112-291, by Ms. Foxx.
- **Nov 17, 2011:** The resolution waives all points of order against consideration of the bill. The resolution provides that the amendment in the nature of a substitute recommended by the Committee on Education and Workforce now printed in the bill shall be considered as original text for the purpose of amendment and shall be considered as read. The resolution waives all points of order against the committee amendment in the nature of a substitute. The resolution makes in order only those amendments printed in the report, to be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question in the House or in the Committee of the Whole. The resolution waives all points of order against the amendments printed in the report.
