Staff Sergeant Salvatore A. Giunta Medal of Honor Flag Resolution - Provides that, upon request of a Medal of Honor (Medal) recipient or immediate family member, the Representative of such recipient or family member may provide to the recipient or family member a U.S. Capitol-flown flag, together with a certificate stating that such flag has been flown over the Capitol in honor of the service and sacrifice of Medal recipients.
